TERMS AND CONDITIONS FOR ESTABLISHMENT OF OPOLFED CHICKEN FRESH
OUTLET ON PPP MODE AT CDVO OFFICE CAMPUS, SUBARNAPUR, SONEPUR.

1. The selected entrepreneur has to sell poultry and poultry products only at the chicken fresh outlet, other products are not allowed.
2. The selected entrepreneur has to install semi-automatic poultry processing unit in side of the outlet.
3. The selected bidder has to establish the chicken fresh outlet at his own cost as per the specification design provided by OPOLFED.
4. The selected bidder has to deposit Rs. 1,50,000/- (Rupees one Lakh fifty thousand) only as security deposit amount, which is refundable without any interest.
5. The selected bidder has to deposit six months' rent in advance.
6. The monthly rent of the outlet will be enhanced @10% on completion of each calendar year.
7. The selected bidder will be given provisional permission for establishment of OPOLFED Chicken Fresh outlet on PPP mode on an area of 625 Sq.ft (25' X 25') at CDVO Office Campus, Subarnapur, Sonapur initially for period of fifteen years and it will be renewed only on satisfactory performances.
8. The selected bidder has to keep the premises hygienic, neat & clean and properly maintain the sanitation of the surroundings of the outlet.


